2- Zone (2) second / Sulaymanya governorate

The project site is Zone (2) second / Sulaymanya governorate which covers the all districts, sub-districts, collected communities and villages.

Water directorates in this zone are forms (Directorate of Sulaymanya Water, Directorate of Sulaymanya Surrounding Water).

### 3- Zone (3) third Dohuk governorate

The project site is Zone (3) third / Dohuk governorate which covers the all districts, sub-districts, collected communities and villages.

Water directorates in this zone are forms (Directorate of Dohuk Water, Directorate of Dohuk Surrounding Water).

4- Zone (4) fourth /(Halabja governorate, Garmyan administration and Rapareen administration)

The project site is Zone (4) fourth / (Halabja governorate, Garmyan administration, Rapareen administration) which covers the all districts, sub-districts, collected communities and villages.

Water directorates in this zone are forms (Directorate of Halabja Shahid Water, Directorate of Kalar Water, Directorate of Garmyan Surrounding Water and Directorate of Rapareen Water).

#### Objects

One of the strategic plans of the General Directorate of Water and Sewerage as the first step is supplying and installing water meters all over Kurdistan region to cover all the water consumers and the second step is implementing the project of "systemizing collection of water fee", to obtain the current and future needs to support economic and social development and providing water services at the highest standard levels. Considering increasing in the population growth and supplying of potable water which leads to fill the gaps in the water coverage services and institution, we need the project of "systemizing collection of water fee".
