Terms and Conditions

1. The bid should be submitted in a sealed cover superscribed as “Tender for Auction of Diplomatic Car” and addressed to “Vice Consul (Admin), Consulate General of India, 1010, Dream City, Erbil. The last date of submission of bids is 13.08.2026. The Bid should contain:

(a) General Information as per Annexure I

(b) The Financial Bid as per proforma in Annexure II. Quotation should be valid for at least 90 days.

2. The bid will be confirmed in favour of the person quoting the highest rate in respect of that vehicle.

3. The bids will be opened on 20 August 2026 at 1500 hrs before the bidders or their representatives.

4. 50% of the bid amount is to be deposited by the highest bidder, within 48 hours on being declared successful, by way of bank transfer (the details of the bank account will be shared with the successful bidder) or bank deposit.

5. On final acceptance of the bid, the remaining 50% amount is to be deposited by the highest bidder within one week of communication of acceptance to him, failing which 50% amount already deposited shall stand forfeited. After the deposit, the vehicle will be handed over to such person, after executing necessary documents. The successful bidder shall make his own arrangement for the purpose of taking delivery of auctioned vehicle.
6. Conditional bid will not be entertained.
7. Consulate General of India, in its discretion, reserves the right to reject or accept any or all the bids, at any time, without assigning any reason thereof.
8. It shall be presumed that the bidder has fully inspected the car before the auction. Consulate General of India will not be responsible and shall not entertain any complaint in respect of any issue in the vehicle.
9. The Officers/staff of Consulate General of India shall not be permitted to participate in the auction.
10. The successful bidder shall get the vehicle transferred in his/her name as per rules, at his own cost and responsibility, immediately. Consulate General of India shall not in any manner be concerned with or responsible for registration of the vehicle, and will have no liability whatsoever.
